Dear Accelerated Learning Laboratory Parents,

This letter is in regard to the program that the State of Arizona has in place to help our school. You can make a contribution of up to \$200.00 (single) / \$400.00 (married) to a special fund at A.L.L. to be used for our children (more on how this fund is used later). A \$1 per \$1 refund of your money! Your accountant or tax preparer should be well aware of this program and be able give you more information.

The school is required to keep this money in a special separate fund. The state does not allow this money to be used in the classroom or to pay teachers' salaries. This money may be used for academic and recreational extra-curricular activities which support the school mission: enrichment, after-school classes, field trips, educational trips, after-school sports, field day awards, homework helper class, Saturday school and supplies (tumbling mats, sports equipment, etc.)

The contributions must be made by December 31 of this year in order to claim the credit on your tax return due by April 15, 2007. Just fill out the enclosed form and drop it at one of the school offices, or mail it to the school with your check made out to "A.L.L. tax credit donation". Audrey will deposit these checks into this separate A.L.L. account.

Anyone who pays Arizona state income taxes may contribute: parents, grandparents, aunts, uncles, friends, co-workers, etc. In effect, what you are doing is redirecting your state tax dollars from the general fund to your children's school. With a little effort, we can make quite a large amount of state tax dollars available to our children, with no extra cost to us.

Remember, this ends up not costing you a penny. I urge you to take advantage of this win-win situation to benefit our kids.
